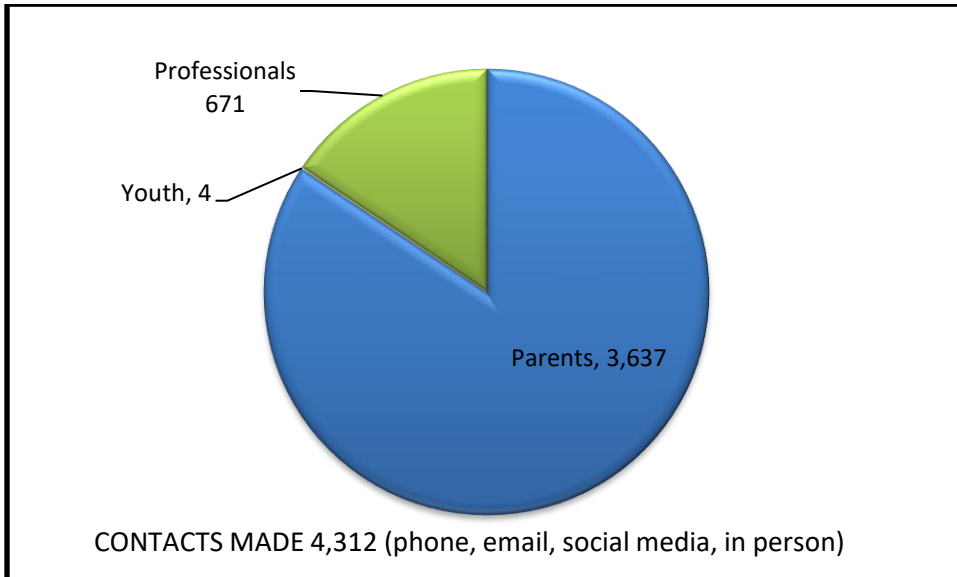

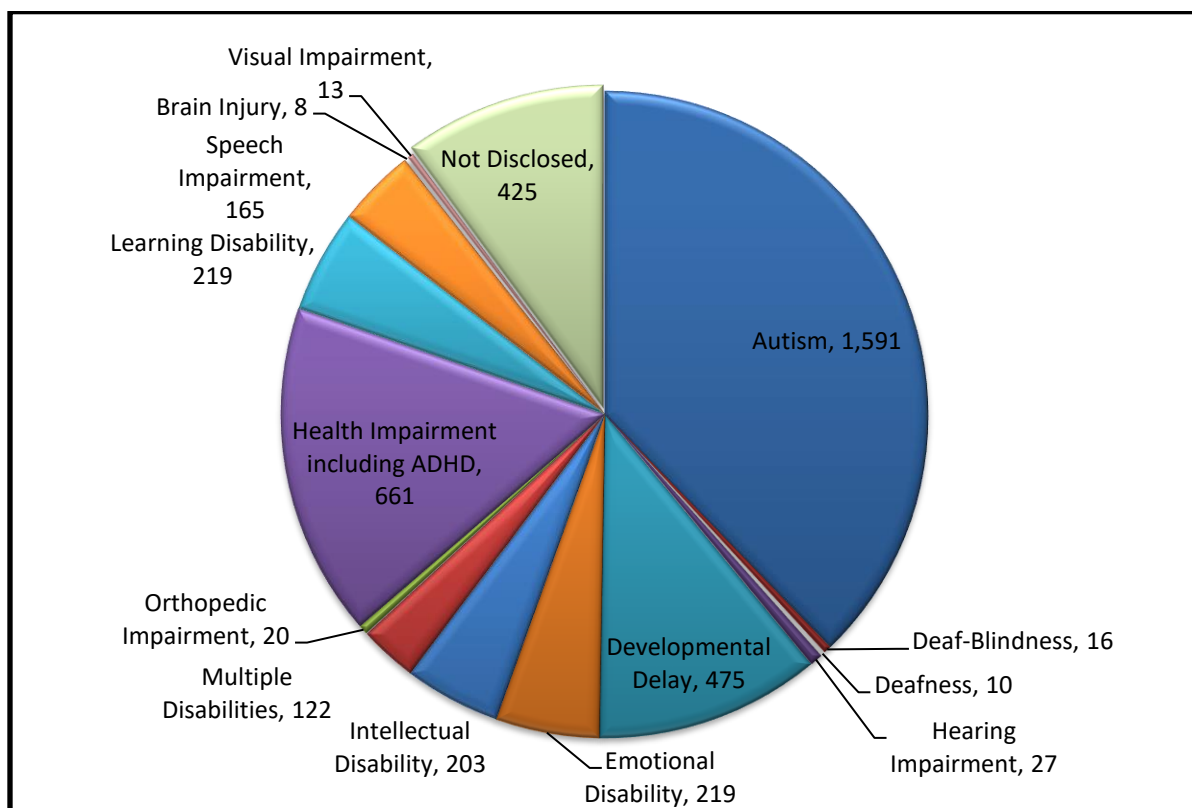

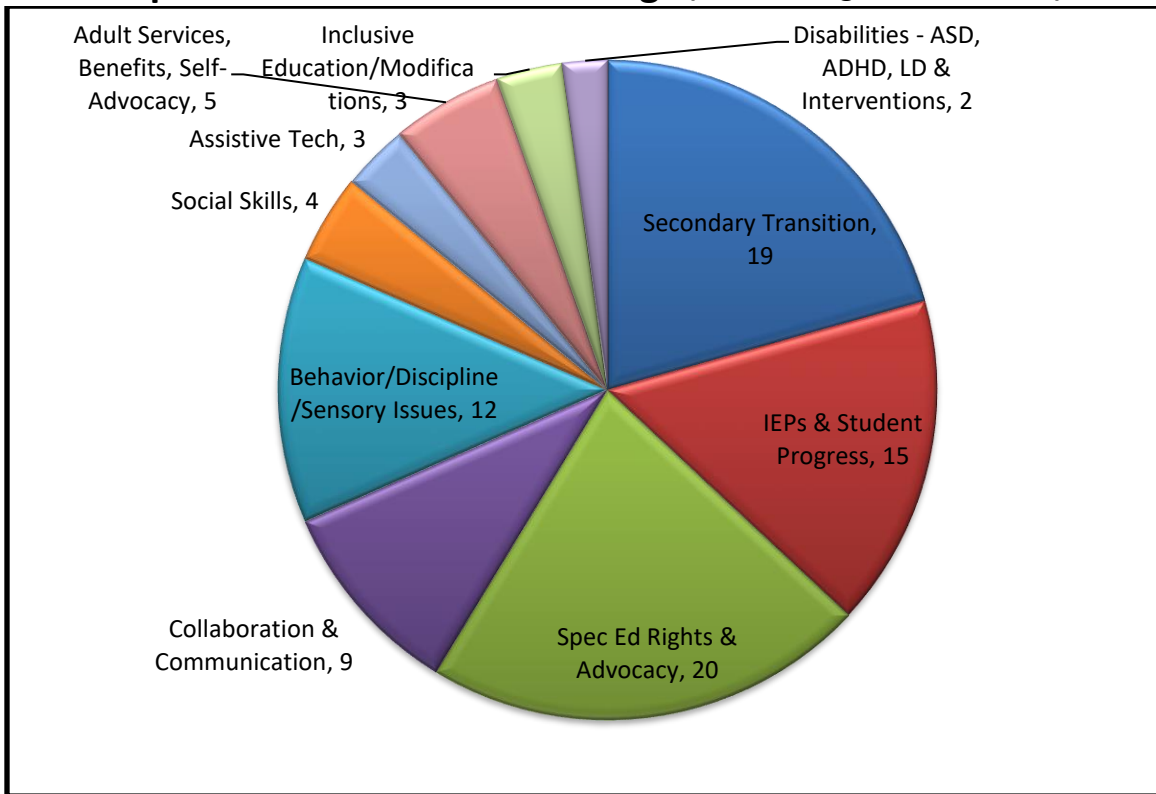

DISABILITY OF CHILD – duplicated count Parents who contacted Family Matters or attended a training

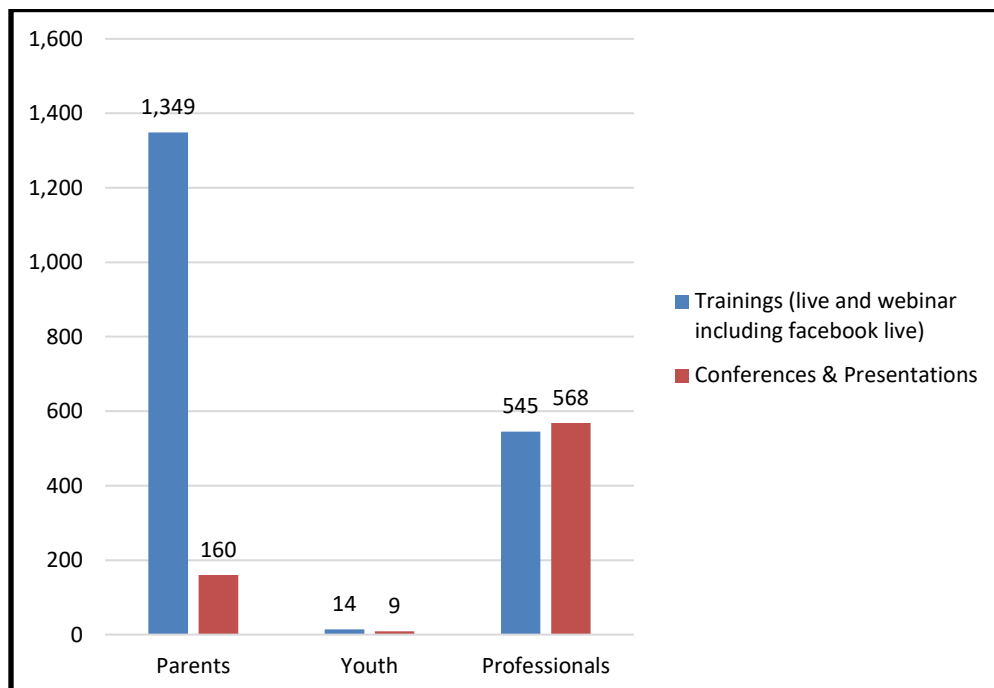
