2023 brought many changes to Family Matters Parent Training and Information Center. In September we said goodbye to our program founder and longtime Executive Director, Debbie Einhorn. Many of you know Debbie and the incredible advocacy work that she has done for families across Illinois. Family Matters PTIC remains endlessly grateful for her vision and leadership. Simply put, Family Matters PTIC would not exist without Debbie's tireless advocacy.

The challenges for families that we serve continue. Families reach out for support and guidance in the special education process, IEP development, seeking access to community resources, struggling with mental health and behavioral support needs within the classroom, and looking for assistance with transitioning to adulthood. 




2023 PROGRAM HIGHLIGHTS
