To provide education and support to families of children with disabilities as well as to professionals in the field. In the fiscal year ended September 30, 2025, 87 live and virtual trainings were held throughout Illinois, reaching 849 duplicated professionals, 601 duplicated parents, and 99 duplicated youth. Additionally, 1,824 duplicated individual contacts were made with parents and 395 duplicated individual contacts were made with professionals. Overall, 441 unduplicated families were served.
